# Background

#### Context

# Tackling Serious and Organised Corruption (TSOC) Programme, Malawi

The Basel Institute has been commissioned by the UK Foreign, Commonwealth and Development Office (FCDO), Malawi, to implement the Tackling Serious and Organised Corruption (TSOC) programme. The programme focuses on strengthening investigation and prosecution capacity with a view to recovering stolen assets. In addition, the programme supports a range of prevention-related activities in relation to the anti-money laundering and counter financing of terrorism (AML/CFT) framework and engages with non-state actors such as journalists, civil society organisations, and the private sector.

Based on our research conducted on the private sector in Malawi, the work will focus on corruption prevention activities in procurement relating to infrastructure and construction. There will be a particular focus on corruption reporting mechanisms, early detection tools, and collective mitigation strategies that can help reduce opportunities for corrupt practices.

## Objectives:

- Conduct Focus Group Discussions (FGDs) to better understand corruption risks in the
  tendering process, the mitigation tools that currently exist in Malawi and ultimately
  brainstorm viable steps and mechanisms to effectively reduce corruption before it
  manifests in infrastructure projects. Stakeholders will include (1) company
  representatives and industry associations (2) active multi-stakeholder initiatives and (3)
  mandated corruption response bodies.
- Lead and coordinate the ongoing discussions and engagement with a core stakeholder group to ensure stakeholder buy-in and propose further guidance for proposed activities.

## Deliverables:

- Produce a research report summarising the status quo of corruption reporting mechanisms in Malawi in preparation for the FGDs.
- Plan and conduct three FGDs in line with the Basel Institute's Collective Action methodology.
- Write up a post-delivery report, identifying the participants, summarising the discussions, and key take-aways and action items.



• Identify a key-stakeholder group and facilitate two follow-up meetings and record nextsteps proposed in coordination with Basel Institute.

#### Competencies:

We are looking for a registered local partner organisation with a successful track record of working with both the private and public sectors, and capable of facilitating the development of a collaborative private sector-oriented corruption prevention approach.

# Institutional requirements:

- Experience working in donor-funded programmes in the private sector and/or anticorruption context.
- Experience working collaboratively with private and public sector stakeholders
- An extensive private sector network that can be engaged
- Strong research capabilities and resources
- Established organisation registered NGO or company with a local office, with a minimum of 15 staff preferred

Personal competencies of the implementing expert/s:

- At least 10 years of experience working in, or with the private sector
- Thorough knowledge of the business landscape in Malawi
- Native-level English speaking and writing skills
- Strong track record in research and report writing
- Experience working with senior-level private sector and government employees

#### Remuneration

The Basel Institution will review expressions of interest received in accordance with the competency criterias outlined. Shortlisted applicants demonstrating credible experience, expertise, and the requested contact details to assess the delivery of their past work will be invited to submit a financial proposal for their work.
